Hale & Common cont.... Cows grazing on common had escaped twice last month, broken post on old fencing. Mr Quinn had attended to help put back in fenced area and had repaired rotting wooden post he had erected. The Quinn's had spoken to Tim Allen re the filling in of the bottom pond and the strimming of thistles on the grazing & surrounding area. Cllr Clark: It was Tim Allen who assisted with the original Natural England Scheme who should be fully aware that there are many conditions & restrictions attached to the HLS. It had been noted that there was a protected species of thistles growing in this area, and the pond could not be filled in, it was awaiting the correct time to remove the overgrown bull rushes. Clerk agreed to look at the agreement for the above information. Mr Quinn to be informed.

NLC will purchase, install& be responsible for these units. Cllr Clark proposed that we send an expression of interest. Discussion took place on location, agreed that the village hall was out of the way, Cllr Clark; would be willing to have erected on wall of Storms Farm, cost of electricity was estimated to be in the region of 80pence a month. Two hours training would be given to any volunteers if requested but unit gives out verbal instruction. Resolved: That expression of interest be sent Clerk to action.

NLC Lincolnshire Lakes Design Guide Consultation;

Lincolnshire Lakes AAP already adopted; The guide is to ensure high quality development takes place. Cllr Bottamley: Should send observations re the possible increase of traffic which may come through the village following the alteration to the road network, de-trunking the M181 and placing round-a-bout on Scotter Road/ West Common Lane to access the M180. Clerk advised this is not the remit of this consultation, just the internal area of the Lincolnshire Lakes Development site. Members agreed that the roads leading out of the village in all directions were in desperate need of attention.
