**Report on Queens 90<sup>th</sup> Birthday Event Min 87/2016**

The account had been received, total spend £1085.39, cash held £129.00, amount owing £956.39, this amount was approved for payment. Clerk reminded Members that we had received the grant of £250 from NLC. **Playing Field/Village Hall Matters Min90/2016**

Cllr Clark reported that Mr Coy and his brother had cut the playing field two or three times during the last month which was much appreciated.

**Hale & Common Min 91/2016**

Discussion took place on grass cutting down the hale road, this has been cut by Cllr's Clark & Stamp free of charge over a period of time proposed should be paid for fuel etc in future. Cllr Bottamley was against paying for work that in his opinion NLC should carry out, he was also concerned that children could run off the playing field straight onto the road. Cllr Clark stated that NLC had never cut the grass on the hale road but did cut verges in the village on occasions. Cllr Stamp ; drivers could see the play area and adjust their speed accordingly, he was more concerned that the bend on the hale road would be more of a hazard if the grass was not cut.

Proposed that claim for fuel should be made for work carried out on behalf of the Council ; Agreed.  
Two items to be brought to the attention of Mr Sanderson NLC PROW Officer : Pingles Footpath not cut ; No posts had been erected adjacent to the footbridge over the Beck to protect damage from livestock.  
Clerk reported conversation with Mr Tom Dennis, Trentside Angling Club, he had filled the water trough using the clubs pumps to create a water supply for Mr Quinn's cows and would ensure it was filled on a regular basis, agreed this was a kind gesture & good to see users of the area working together. Cllr Robbins ; since the fishing club had carried out all the work on the trees etc the area was now looking really green, best it's looked for a long time. He noted that they had finished work on the bridge on the far side of the lake.
