Councillor's Reports Min 12/2018

Cllr Cunnah had distributed letter from Mr Moyes at the start of the meeting. The letter was a complaint that he had been denied access to the lake area where he had some years ago scattered his late wife's ashes. At some time Trentside Angling Club had cut down some trees that were causing problems, this included a tree that the Moyes family used to place flowers on anniversary's. There used to be a bench nearby which the Angling Club had agreed to replace, this had never happened. Complained about the new Otter Fencing surrounding the lake which in his opinion was not required as there are no otters in this area, claiming the gate was locked restricting access. This was disputed by both Members & the member of public present, not locked, Request combination of main access gates to allow vehicular access. Cllr Clark agreed to arrange a meeting on site with Mr Moyes & Mr Dennis from Trentside Angling Club to discuss matters further. Report on site meeting to February agenda. Cllr Cunnah ; Interest in the village to form an angling club taking over the lake from the current leaseholders, requested sight of lease. Cllr Clark ; Trentside Club had invested their funds into stocking the lake, paying 50% of the cost of the otter fencing and carrying out much maintenance work round the lake area. Cllr Staples ; The common is looking good due to the fishing club members taking time to look after the lake area.
