Questions from Members of Public Min 82/2018

Mr Robbins ; Trentside Angling Club had been clearing areas round the fishing pond leaving rubbish on site, area near car park, brambles etc had been cleared but rubbish had been dragged up to the flood bank and left, all need clearing away. Members agreed it was unusual for the club to leave the area in a mess, Cllr Clark to speak to Mr Dennis.

Resolved ; That with changes to attendance ; Cllr Stamp was present, the minutes of the meeting held on Tuesday 14th August 2018 be approved a correct record.

Questions & Updates on the Minutes Min 84/2018

Cllr Bottamley questioned the decision for the grazing of sheep FOC as no discussion had taken place. Cllr Clark ; this had been done to comply with the HLS agreement, Members had been informed at the May Meeting, (min 61/2018) and ratified by those present.

Cllr Clark ; Sheep taken off Common last Friday/Saturday which was earlier than expected. Cllr Stamp ; A sheep had drowned in the Beck. Cllr Clark to contact the farmer for more details.

(NB; Condition that any Contractor employed must have £5m Public Liability Insurance, Parish Council to take out insurance for volunteers) Cllr Bottamley questioned where this would finish up in future years, was against this Partnership. Cllr Clark agreed & proposed we leave until next year then look at again, we will then know from any Councils who take up this agreement if contractors had done a good job. On a vote being taken.

Resolved ; That NLC be advised this Council were not signing up to the Parish Paths Partnership Scheme.

Hale & Common Min 90/2018

Following on from discussion from last meeting (Min 77/2018 refers) on the status of the footpath to the common Cllr Bottamley was still insisting it is a Highway and the gates should not be locked. He produced maps dating back 30/40 years ago which did show it as a Highway. Cllr Robbins had been on NLC website now dropped off list of adopted Highways, he agreed with other Members that the gates had been a success in preventing fly tipping, drug users etc. we have received no complaints from residents of the village. Cllr Bottamley ; there were a number of dwellings down the bottom, since demolished, we should try again to contact Mr Bowes. Cllr Clark we have tried this before without success, NLC will not take on the maintenance of this footpath as we tarmaced the road some years ago. Further discussion took place. Cllr Clark proposed that we keep the gate locked, on a vote being taken three Members voted in favour, one against ;

Resolved ; That the gate be kept locked as at present.

Correspondence Min 91/2018

Letter from Mrs Nixon on behalf of the Fund Raising Committee who have run several Bingo Sessions to raise money for Parkinson UK, that they are donating the "Bingo machine" purchased by them to the Village hall for use of anyone in the village, plaque to that effect has been placed on the machine. To be included in letter of thanks agreed earlier in the meeting. Bonfire Night to be held on 3rd November. Cllr Clark has agreed to hold the bonfire & fireworks on his field opposite the Village Hall when refreshments ; hot dogs burgers soup etc will be served to include a Licensed Bar. A children's entertainer & disco has been booked, a face painter which will be in the Changing Room. Entrance FOC but donations will be asked for. All proceeds towards a yearly event which was previously held by the Dog & Gun. Cost of Fireworks £500 plus Insurance for the event £120, we are currently inviting local businesses to make a donation towards this event and ask if the Parish Council will make a donation. Resolved ; That the amount of £620 be donated as this

will bring back the Community Spirit of the village.

A meeting will be held by their committee after the October Council meeting to finalise details.

Councillor's Reports Min 92/2018

Cllr Clark advised the bonfire would not be built until the weekend before the event, and is not intended for residents to get rid of household rubbish.
